



## TIGER LEATHER SWEEPSTAKES OFFICIAL RULES

NO PURCHASE NECESSARY TO PARTICIPATE IN PROGRAM. PURCHASE WILL NOT IMPROVE CHANCES OF WINNING.

### 1. ELIGIBILITY

This Tiger Leather Sweepstakes (the "Sweepstakes") is offered only to individuals who are legal residents of the US and at least 18 years of age at the time of participation and have a valid passport.
